# A MESSAGE from the PRESIDENT

Happy New Year to all! We begin the year 2015 with hope and optimism.

**Board Elections:** NNAI is always looking towards the future. Our educated and motivated young adults are the future of all Native Corporations. Over the years our elders have given much time and effort to run the corporation. We recognize that younger people often have new and innovative ideas that, when teamed up with the experience of older board members, can take our corporation to new levels of success. The NNAI Board has already made in-roads in this direction and we would like to continue to move forward toward the future. It's not too soon to start thinking of board elections. We invite all shareholders who are interested in, and qualified for, directing the future of our corporation to consider running for the board.

**Investment**s: Reflecting on the past year, NNAI has made many changes and accomplished much. We continue working on sound investments which will build revenue in 2015.

We have had an ongoing relationship with HilCorp, an oil and gas entity that is active throughout Alaska. Our Corporation provides surface use to HilCorp on an annual basis. This agreement will exist for some years to come. Business with HilCorp has led to other partnerships in the oil and gas industry including land use on NNAI surface estate on the west side of Cook Inlet and development of new gas and or oil wells in Ninilchik and surrounding areas. We look forward to other new business opportunities with our largest oil and gas partner.

**Ninilchik General Store:** We are proud to bring new changes to the store, which will benefit both Ninilchik and NNAI. With our purchase of the NGS building in 2014 we partnered with fellow Native Corporation, UCI/SeaLion and formed the new Ninilchik General Store, LLC. The plan is to expand the existing structure which will add space to diversify offered goods. The current store operation, Ninilchik Trading Company, (owned and operated by Jim and Sharon Clark of Echo Lake Foods), has already supplied our town with dry goods, hardware, fresh produce and a full meat counter. Our expansion will allow them to consolidate their entire inventory under one roof and add more services.

White Mountain: Another subsidiary of NNAI is the entity White Mountain Construction under Summit Holdings. White Mountain is a construction company that bids 8a, government and general construction contracts. Last year this was a significant source of revenue for NNAI. In 2015 we are looking to further pursue other contract sources as the 8a will no longer be a preferential status.

**Christmas:** We were pleased with our turnout this holiday season for our Christmas Parties! The feeling of comradery and togetherness was a wonderful gift the shareholders gave to the corporation. I am confident all who attended enjoyed both food and prizes.

Our **Christmas Dividend** was welcomed and timely. A percentage of our income for the year was issued in the form of \$5.00 per share. (If you have questions regarding your check please contact our office.) The remaining income generated in 2014 has been set aside as an investment for future business endeavors and as an interest income generator for the corporation. Secure, long term investments are the most prominent goal that we have for 2015.

# A MESSAGE from the PRESIDENT

**Cook Inlet Region Working Group:** A 2014 historic event was the formation and participation of the Cook Inlet Region Working Group (CIRWG) in response to the Alaska Energy Authority's (AEA) request for access to Native Land to study and begin the permitting process for the **Susitna Wantana Dam**. As of the end of the year the project had brought in revenue to NNAI and was poised to continue in a very positive way. Unfortunately, due to budget shortfalls, Governor Walker has put this project (as well as five others) on hold. The process of obtaining permits to license construction was stopped just one year short of its fruition. Millions have already been spent to study the potential impact of the project on wildlife and land. This is unfortunate as the clean energy that could be provided by the dam would benefit much of the state of Alaska. I did write Governor Walker and explain our position, encouraging him to at least consider continuing the project to the point of licensing.

**Land:** As I mentioned before we are working towards building a better relationship with the Ninilchik Traditional Council, which will benefit both parties. The idea is to partner in areas of non-commercial resource and land development where the tribe is federally recognized and has the ability to pursue agricultural and other potential development or resource monies. We will provide the use of the land for these projects. The intent is also to consolidate overlapping resource management.

The BLM is required to survey the corners of all native land. Ninilchik has approximately two sections left to survey which will be completed this summer. Our intent is to partner with the selected contractor to finish the administrative side of the project.

**Website:** You may have noticed over the last year the update to our website. It is our hope that you as shareholders utilize this as a tool to easily connect you to the corporation. As always if you would like to contact us we are available in the NNAI Office Monday – Friday.

# NNAI LAND AND RESOURCES OFFICE REPORT—WINTER 2015 <u>NNAI/NRCS - CSP GRANT CONCLUDED</u>

December 31<sup>st</sup> 2014 marked the final close-out date of the Conservation Stewardship Program (CSP) grant that had been received and managed by NNAI since its inception back in 2010. The program was developed and approved out of an offer from the Natural Resources Conservation Services (NRCS), a division of the U.S. Department of Agriculture, to provide up to five years of incentive funding in exchange for enhanced conservation management practices over forest lands owned by NNAI.

Accomplishments under the program included many upgrades to management and access infrastructure throughout the lands owned by Ninilchik Natives Association, Inc. Numerous enhancements and improvements were made to fish stream flow in critical areas on NNAI land where anadromous waters crossed or impacted previously established and newly created roadways.

Through CSP NNAI was given the opportunity to incorporate projects and upgrades which were already scheduled as necessary under the US Forest Practices Act and stream-flow upgrades (culverts & bridges) required under the statutory Habitat Protection Guidelines.

These inclusions provided a mechanism to utilize non-corporate funding sources to accomplish some of the already existing field upgrades that would, potentially, have required NNAI corporate resources.

New Bridges That Protect Anadromous Streams

These accomplishments were not only beneficial to the land and habitat resources of the corporation, they were also recognized by the USDA and the Natural Resources Conservation Service in Alaska, as very vital components in the overall efforts to improve forest land recovery and increase fish stream production and accessibility in Alaska.

These were also very highly ranked priorities to our corporation as both the Ninilchik and Deep Creek watersheds contain many miles of anadromous salmon waterways and critical wildlife habitat. Additionally, the enhancement efforts and treatments provided for under the conservation legislation of the CSP program allowed NNAI to make very significant strides in recovery and long-term enhancements to our existing forest-land holdings here on the Kenai Peninsula.



Much Needed Upgrades of Old Infrastructure

Within the overall efforts and goals achieved by NNAI throughout the five-year implementation pe-

riod, many of our annual goals and accomplishments were given state and national recognition by NRCS and other USDA counterparts. We were recognized as some of the highest ranked accomplishments under the Congressionally modified CSP program that allowed the inclusion of Alaska ANCSA Corporations in the 2008 US Farm Bill.

Throughout this article are photos showing a few of the many enhancements to NNAI natural resource conservation and management that have been made possible with the CSP incentive program. Projects tied to land enhancement and resource conservation are not the only benefit our corporation has gained from the CSP program. Many internal corporate improvements have been seen including the realization of the capacity of the corporation to manage these land holdings and their associated resources.

We express our appreciation to the local Kenai and Homer offices of the NRCS and the National USDA Headquarters for all of their guidance, support and funding appropriations that allowed us to reach our goals under this and other complimentary associated programs over these past five years.

Tribal Member or Native Shareholder?

With the intent to promote shareholder understanding and facilitate shareholder involvement NNAI will now include a newsletter segment corresponding to an aspect of the corporation and its many facets in each newsletter. We would welcome shareholder discussion topics and ideas. You may contact us using the information on page 14 of this newsletter.

It is our hope that this information will help shareholders who desire to explain what they are part of to someone who does not understand where Alaska Native Corporations come from or what being a Native Shareholder means.

Many of our shareholders are Alaska Native. As an Alaska Native you are always an Alaska Native. However, you may or may not be a shareholder of a regional and/or village corporation, and you also may not be a member of a tribe. Some Alaska Natives are just members of a tribe, some are both tribal members and shareholders of a regional corporation, some might not be tribal members but be shareholder, and further yet some might not be members or shareholders, etc. There are many combinations, but you will always be Alaska Native.

If you or your parents or even grand parents were/are Alaska Native and were alive in December of 1971, you were given an opportunity. The Federal Government passed what is called ANCSA or The Act. This was an act by congress that created what we are today. In Alaska not all Native people were enrolled as shareholders of corporations. Being a shareholder was a choice and there were some people who were eligible that did not enroll. This enrollment and inception of the Native Corporation was both the start and finish of the shares. Native corporate shares are private stock. They have no clear monetary value and they can not be traded, bought or sold; these shares are a birthright.

How do they continue then? Well, as with any birthright or inheritance they are passed down lineally. When NNAI started, for example, there were 206 original enrollees on the roster- all with 100 shares and all Alaska Natives. Now the NNAI roster holds 354 shareholders with holdings ranging from 1 to over 200 shares, with a combination of both Alaska Native and non-Alaska Native heritage.

Some shareholders of NNAI stock are also members of a First Nation or Alaska Native Tribe. Within the United States there are many separate governments that oversee a group of people with specific heritage. Many of these governments decide for themselves who is eligible to become a member or be part of that nationality per se. These tribes are federally funded and offer their members support and assistance through US Government programs. If you are a shareholder of a Native Corporation you have probably received a check at some time and are possibly asking yourself isn't that money assistance? The difference is this: a native Corporation will pay you a dividend based on the amount of income they have generated over a set period of time, if they make more money, you make more money; whereas, a tribe will provide assistance from a government fund based on need and eligibility.

As a Native Corporation, NNAI encourages shareholder involvement and participation. As our elders start to retire we look for youth to mentor and receive the heritage of knowledge. If you would like more information on NNAI please contact our office using the contact information on page 14.


